



# **Invitation to International German Para Athletics Championships**

in Erfurt**

**Active, U20, U17, Seniors  
All sports classe**

Athletes from federations banned by the International Paralympic Committee (IPC) are excluded from the competition.

*U14 and U12 can start out of classification in the U17 in the advertised disciplines*

**Start of the competition:** Saturday, 15 June 2024, 09:00 am

**Age groups:** Active, U20, U17, Masters and seniors

It should be noted that the age groups apply in the year in which the athlete reaches the corresponding age.  
U20 can either start in their age group or in the open class.  
Senior athletes can choose whether they want to start in the masters class or in the existing senior age group. Starting in different age groups during the event is not permitted.

- Late registrations:** are possible up to 60 minutes before the start of the respective event for an additional fee of 50,00 Euro per start
- A confirmation of the registration will NOT be issued. In the event of rejection, the national association will be notified. Verbal or telephone registrations cannot be considered.
- Entry deadline and online link:** Entries are possible until **24.05.2024**.  
The lists of participants can be viewed at [www.laportal.net](http://www.laportal.net) after the closing date for entries.
- Starting documents:** Issue at the Steigerwaldstadion (follow the signs)  
Friday, 14.06.2024, from 4pm until 7pm  
Saturday, 15.06.2024 from 8am
- Pitch:** Friday, 14.06.2024 5:00 pm to 7:00 pm Saturday, 15.06.2024 from 8:00 am
- Pitch cards:** For the German Championship all Participants will be issued with pitch cards for each registered discipline. These are included in the starting documents that each club receives. The pitch cards must be checked for completeness and corrected if necessary (spelling mistakes, best times).  
  
Pitch cards must be handed in **at the pitch at least 60 minutes before the respective start**. In case of a relay ticket, this must include the names of the runners in the order in which they are to start.  
  
On Friday from 5pm to 9pm there will be the opportunity to hand in your pitch cards when collecting your starting documents. This option is especially recommended for participants whose events start on Saturday at 9:00 am!
- Entry fee:** International athletes 50,00€ lump sum  
  
Entry fees need to be paid cash on-site.

- National classification:** After registration possible on Friday and Saturday in the Athletics hall, Johann-Sebastian-Bach-Straße 2, 99096 Erfurt.

- Callroom:** Track competitions: 20 minutes before the start of the competition in the callroom Field competitions: 30 minutes before the start of the competition in the callroom
- Equipment inspection:** up to 60 minutes before the start of the competition
- Medical service:** Medical staff / medical service on the site (DRK Erfurt)
- Travelling expenses:** The DBS does not cover the costs of travelling to and from the event, accommodation and meals for participants! You are responsible for organising your own accommodation.

**Conditions of participation:** According to the currently valid regulations, athletes can only take part in championships if they fulfil the following conditions:

- Each participant is responsible for ensuring that he/she is fit to fulfil the health requirements of training and competition. To determine fitness for sport and competition, the DBS expressly recommends that a basic sports medical examination be carried out at least once a year.
- They have at least one national classification. If there is no classification, a classification slot can be issued.
- Entry fees paid will not be refunded in the event of non-participation by individual starters or teams/relay teams!

**By submitting the entry form, the clubs guarantee compliance with the participation requirements.**

**Technical notes:**

- The Para Athletics Championships are organised according to Competition rules of the Para Athletics Department using the rules of World Para Athletics ("Rules & Regulations", current edition).
- Participants are free to start with or without spikes with thorns up to 6mm.
- Helmets are compulsory for all wheelchair races.
- Athletes in class T11 are obliged to wear eye plasters and a face mask for all disciplines.
- Athletes with accompanying runners in classes T11 and T12 are reminded that the guide bands must comply with the requirements of "World Para Athletics Rule 6, 18ff".
- Participants in standing disciplines may not use wheelchairs or other vehicles within the competition area.

**Heats:**

All heats will be organised as time heats. The division of the heats and the qualification criteria are determined according to the "WPA Rules and Regulations" (current version). The race classification is based on the times submitted in advance. If no times are available, the slowest times will be used.

**Start numbers and safety pins:**

The start numbers issued must be worn unchanged on the chest. Wheelchair users must attach their race number to the back of their racing wheelchair or throwing chair. You must bring your own safety pins.

**Realisation of the competition:**

In technical competitions in which two or more starting classes start together (without the minimum number of participants for one class being reached), starts in different age groups are permitted, but no double starts in different age groups in the same discipline.

○ **Active**

The competition is divided into standing and sitting. In the wheelchair competitions, a further distinction is made between para- and quadriplegics. Individual sports classes will be scored separately if at least three athletes per sports class are on the list of participants for the corresponding competition after the closing date; otherwise the performances will be scored in an open class according to the DBS points system. The factors are applied separately for each discipline/class.

○ **Youth U20, U17**

The youth classes U20 and U17 start in an open class; the throwing competitions are carried out with the corresponding weights. The performances - including heats - are assessed in mixed classes using the DBS points system. If the minimum number of 3 participants (m/f) is reached in a sport class, the sport class will be scored.

○ **Senior citizens**

The senior athletes compete in an open class. All disciplines are scored using the DBS points system. If the minimum number of 3 participants (m/f) is reached in a sport class, the sport class will be scored.

**Exclusion of participants:**

Participants who have acquired further eligibility to participate in preliminary or intermediate heats but fail to do so will be excluded from participating in further competitions at this event. An exception is possible by presenting a medical certificate. In the event of a competition overlap, the relevant judges must be informed.

**Title** The title of German Champion is only awarded to athletes who compete for a German club and as soon as the competition has reached the minimum number of three participants:

U17/U20 "German Youth Champion"

Active "German Champion Seniors

"German Senior Champion

**Certificates** For national participants, certificates will be awarded for 1st - 8th place in each competition. International participants will receive a certificate if they have achieved at least 8th place in the joint ranking.

**Anti-doping** **Doping is prohibited according to the regulations of the DBS.**

The Anti-Doping Code of the DBS as well as the regulations of the WADA, the NADA and, for international events, the anti-doping regulations of the of the relevant International Sports Federations (collectively: anti-doping regulations).

**By submitting the entry form for the event, the participant recognises the anti-doping regulations in their current version** (available at [www.dbs-npc.de](http://www.dbs-npc.de)).

Doping tests may be carried out on a random basis.

**By submitting the entry form for the event, the participant recognises the jurisdiction of NADA for the results management procedure and the disciplinary procedure in accordance with the NADA Code and the jurisdiction of the German Court of Arbitration for Sport at the German Institution of Arbitration in Cologne for contentious proceedings in the first instance, also for interim legal protection, in accordance with the DIS Sports Arbitration Rules, excluding recourse to the ordinary courts of law.**

Each participant is responsible for checking the doping relevance according to the current WADA Prohibited List in the case of therapeutically necessary intake of medication and/or therapeutically necessary use of methods. The following must be observed:

- For athletes in the NADA test pool (ATP, NTP or RTP), the following applies: the use of prohibited but therapeutically necessary drugs and/or methods must be proven by a valid medical exemption authorisation (TUE).
- For athletes without test pool membership, the following applies: after a doping control and following a request by NADA, a retroactive Therapeutic Use Exemption (TUE) must be applied for. No application can be made in advance. As soon as

If additional steps need to be taken by the athletes concerned, NADA will contact them immediately and provide comprehensive information.

## **Classification**

The international classification takes precedence.

If there is a difference between the international and national classifications, the international classification always applies. National and international classifications must be recognised. Protests can only be submitted via the official channels of the DBS classification code or WPA classification rules.

## **Liability**

The DBS and its organs shall only be liable for damages in the event of intent and gross negligence within the limits and scope of the available liability insurance cover and limited to the typical foreseeable damage. The exclusion of liability does not apply to damages resulting from injury to life, limb or health. The insurance contract can be inspected at the DBS office or requested for inspection.

## **Protests**

Protests during the event must be submitted in writing to the referee/arbitration court by the team manager or the athlete concerned, stating the reasons for the protest. The protest must be submitted no later than 30 minutes after the announcement of the results.

- A protest fee of € 50.00 must be deposited with the submission of the protest. The protest fee will be refunded if the protest is upheld.
- A protest against the decision of the arbitration tribunal can be lodged with the responsible department board. The protest must be submitted in writing to the DBS office within 48 hours of the end of the event. The protest fee of €100.00 must be enclosed with the protest in the form of a crossed cheque. The protest fee will be refunded if the protest is upheld. The postmark is valid.
- The further course of proceedings is governed by the legal system.



- If the reason for the protest only becomes known after the end of the event, the protest must be submitted in writing to the responsible departmental committee via the DBS office no later than 48 hours after the end of the event. The protest fee of €75.00 must be enclosed with the protest in the form of a crossed cheque. The protest fee will be refunded if the protest is upheld. The postmark is valid.

**Leaflet**

Participants and s u p p o r t e r s will receive organisational information in the form of an information sheet, which will be handed out to the clubs together with the starting documents.

**Penalty fees**

If a participant does not take part in a competition, a penalty fee of 20 € per non-appearance is due. This will be checked by the organiser and a corresponding invoice will be sent to the club via the respective LV.

**Data protection:**

The German Disabled Sports Association and National Paralympic Committee e.V. (DBS) and the Thuringian Disabled and Rehabilitation Sports Association e . V. in cooperation with HSC Erfurt e.V. undertake to handle personal data in a legally compliant manner in accordance with the EU General Data Protection Regulation (DSGVO) and the Federal Data Protection Act (BDSG new version) and provide information here about the joint data processing in the context of registration and participation in competitions, as well as the creation and publication of image and sound data.

If this data is not p r o v i d e d , participation in the advertised competition is not possible.

The recording and storage of image and sound data is based on the informed and voluntary consent (Art. 6(1) lit. a and Art. 7 GDPR), which the participants give implicitly by participating in the event. This consent can be revoked at any time without giving reasons. The lawfulness of the processing until

at the time of cancellation is not affected by this. In the event of cancellation, we will delete your data as far as possible, notify any recipients of the data and end any publication that may have taken place. If you do not consent or revoke your consent before the end of the event, participation in the event may no longer be possible. Please address any revocation informally to the DBS, the organiser or the above-mentioned data protection officer.

By submitting the entry form, participants agree to the publication of image and sound data (photos and videos), which are made in the context of this event and used free of charge for communicative purposes, taking into account the respective context. The photos and/or videos serve the public relations work of the DBS (consent to publication within the meaning of the KUG).

This consent expressly includes, in particular, the dissemination and publication via all distribution channels and media (e.g. press releases, homepages, publications, videos, social media) of the German Disabled Sports Federation and National Paralympic Committee e.V., the German Disabled Sports Youth, the DBS regional and specialist associations as well as participating cooperation partners and supporters.

Participants are aware that photos and/or videos can be accessed on the internet by anyone. Despite all technical precautions, it cannot be ruled out that such persons will continue to use the photos and/or videos or pass them on to other persons.

The legal basis for disclosure and publication is the "legitimate interest" in public relations within the meaning of Art. 6(1) lit f GDPR).

In the event of an objection, it should be noted that a general deletion of recordings, especially on the Internet, cannot be fully guaranteed and publications will continue to be distributed until they are (possibly) republished.

Your data may be passed on to processors, joint controllers and independent third parties to the extent necessary to achieve the purpose. This includes the following categories:

If data is published on the internet (including social media, for example), it may be transferred to third countries if the platforms used or their partners store or provide this data outside the EU. No other direct transfer to organisations or persons in third countries outside the EU is envisaged. Profiling does not take place.

The data relating to the organisation of the competition will be stored for three years and the results data for historical sporting purposes until the purpose no longer applies.

In addition, all participants are aware that:

1. you have the right to information from the DBS about your personal data at any time, as well as the right to rectification or erasure or restriction of processing and the right to data portability, provided that the legal requirements are met;
2. you can object to the publication of your data, provided that you can demonstrate reasons relating to your person that justify overriding interests in protection;
3. they have the right to lodge a complaint with a supervisory authority at any time. ## New starting class: Masters

### Masters for athletes aged 40 and over

At the annual departmental meeting, it was decided to offer a new age group on a trial basis in 2024.

The aim is to make the IDM Para Athletics more interesting. The throwing weights correspond to those of the over-40 age group.

Registration in this class is voluntary. The existing senior age group will continue to be offered. During the trial period, it will be evaluated whether this age group can be offered permanently. The final decision will be made at the departmental meeting at the end of 2024.

**When registering, please state explicitly whether you wish to start in the senior class or in the master class. It is not possible to start in both classes.**

## Evaluation of the German Champion titles

The competition regulations stipulate that a German championship title is only awarded if at least 3 participants have taken part in the competition. Due to the large number of sports classes, it often happens that no German championship title can be awarded. In order to make participation in the German Championships more attractive again, the department meeting decided to introduce a new classification system on a trial basis. Based on the Invictus Games system, sport classes will be judged together in a collective sport class according to RAZA points. The athlete with the most points is awarded the title of "German Champion", provided at least 3 participants have taken part.
